NOTICE

The South Dakota Bankers Benefit Plan (“Plan”) is a self-funded group health plan sponsored by the Trustees of the South Dakota Bankers Benefit Plan Trust (“Trust”). The Plan is comprised of various participating employer banks who are members of the South Dakota Bankers Association. The Plan constitutes both a bona fide association health plan and a single employer plan within the meaning of the ERISA Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan also constitutes a multiple employer welfare arrangement within the meaning of Section 3(40) of ERISA and a multiple employer trust within the meaning of Section 58-18-88 of the South Dakota Insurance Code.

Plan assets are held in trust pursuant to the terms of the Trust agreement. All benefit claims and allowable expenses of the Plan and Trust are paid from the Trust. The Trust constitutes a voluntary employees beneficiary association within the meaning of Internal Revenue Code section 501(c)(9) and is funded by both employer and employee contributions. South Dakota Bankers Insurance & Services, Inc. (“SDBIS”) is the plan administrator for purposes of ERISA. SDBIS receives a fee for its services directly from participating employer banks and receives no compensation or other fee from the Trust. Wellmark Blue Cross BlueShield (“Wellmark”) provides claims administration and provider network access services. Wellmark does not assume any financial risk or obligation for claim payment amounts.

If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. Well-child care, in- <u>network</u> <u>preventive care</u> , outpatient xray/lab and services subject to <u>copayments</u> are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Does this plan provide Minimum Essential Coverage? Yes
