NOTICE

The South Dakota Bankers Benefit Plan ("Plan") is a self-funded group health plan sponsored by the Trustees of the South Dakota Bankers Benefit Plan Trust ("Trust"). The Plan is comprised of various participating employer banks who are members of the South Dakota Bankers Association. The Plan constitutes both a bona fide association health plan and a single employer plan within the meaning of the ERISA Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan also constitutes a multiple employer welfare arrangement within the meaning of Section 3(40) of ERISA and a multiple employer trust within the meaning of Section 58-18-88 of the South Dakota Insurance Code.

Plan assets are held in trust pursuant to the terms of the Trust agreement. All benefit claims and allowable expenses of the Plan and Trust are paid from the Trust. The Trust constitutes a voluntary employees beneficiary association within the meaning of Internal Revenue Code section 501(c)(9) and is funded by both employer and employee contributions. South Dakota Bankers Insurance & Services, Inc. ("SDBIS") is the plan administrator for purposes of ERISA. SDBIS receives a fee for its services directly from participating employer banks and receives no compensation or other fee from the Trust. Wellmark Blue Cross BlueShield ("Wellmark") provides claims administration and provider network access services. Wellmark does not assume any financial risk or obligation for claim payment amounts.

The Following Supplemental Notice to Applies to Participating Employers Pursuant to South Dakota Administrative Rules 20:06:57:10, 11:

"This policy is issued by a multiple employer trust. Multiple employer trusts are not subject to all of the insurance laws and regulations of South Dakota. This policy is not covered by the South Dakota Life and Health Insurance Guaranty Association in the event of plan failure. Your participation in this plan makes you subject to assessments for health plan costs. By accepting coverage, you must participate in this plan for a minimum of three years to avoid penalties for early departure."

Are there services covered before you meet your <u>deductible</u> ?	Yes. Does this plan provide Minimum Essential Coverage? Yes
