Associate membership dues are \$750 annually (Jan. 1 to Dec. 31). Applications approved after July 1 are prorated at \$375. Applications approved after Nov. 1 will pay the full amount of \$750 for the following year's associate membership dues. Upon board approval, company will be invoiced for associate membership dues.
